# Roo Bus TN Festival Ticket Contest Rules

## 1. Eligibility

Roo Bus TN Festival Ticket Giveaway (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Roo Bus and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

# 2. Sponsor

# 3. Agreement to Official Rules

#### 4. Contest Submission Period

The Contest submission period begins on April 03, 2023 at 12:01 AM Central Time Zone and ends on April 30, 2023 at 11:59 PM Central Time Zone (the "Contest Submission Period"). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods:

# 5. How to Enter

Online: This method of entry will be available by visiting our website (http://www.therealroobus.com) and following the directions provided to fill out the entry information, and submit.

Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period, regardless of method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

# 6. Prize Drawing

On or about May 01, 2023, the Sponsor will choose four entries. The final four entries will be placed online on the Roo Bus Twitter account, where participants will vote for their favorite. The final selection will be made at the end of the poll period.

The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about May 04, 2023. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

## 7. Winner Notification

The potential winner will be notified by email, mail or phone. The potential winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. Festival tickets delivery method is at sole discretion of Festival Entities which will be either sent to winner by mail, email, mobile ticketing or placed at venue Will Call the day of concert under the winner's name. Winner must be present to pick up tickets and a valid photo ID will be required if tickets are placed at Will Call. Festival Entities reserve the right to revoke full or partial prize from any winner or guest who it or venue personnel deem may, in its sole discretion, be intoxicated, be a safety risk, have violated any festival or venue policy or law, or may bring Festival Entities into disrepute. Resale of Festival tickets is prohibited. By claiming tickets, you agree to Festival Terms of Use and to abide by the health and safety measures in effect at the time of the Festival, which may include, but not be limited to, wearing masks, providing proof of vaccination status and/or providing proof of negative COVID-19 status. ## 9. General Conditions

In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Contest is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may, in its sole discretion, either (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Contest and, in the event of termination, award the prize at random from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.
